- > **SAVE THE DATE** NCOA's Annual Business Meeting and Awards Tribute will be held July 11-14, 2017. Host hotel is the Golden Nugget, 129 E. Fremont Street, Las Vegas, NV 89101.

All individual room reservations must be made directly with the Golden Nugget at (800) 331-5731. You MUST specify you are with the NCOA 2017 Convention. Reservations must be made prior to June 15 to guarantee rate. Reservations made after June 15 will be subject to space/rate availability. Check-in time at the hotel is 3:00 p.m., check-out is 11:00 a.m.

The Golden Nugget requires a first night's room and tax deposit to accompany each reservation request. It is the policy of the Golden Nugget to charge the first night room and tax deposit to the individual's credit card at the time the reservation is made if a credit card is used in lieu of a cash deposit. The deposit is refundable if cancellation occurs at least 48 hours prior to scheduled arrival.

- A variety of commercial shuttle services are available from McCarran International Airport to the hotel. The shuttles services are located on the west side of the baggage claim area, outside exit doors 7-13. Round trip ticket cost is approximately \$20 per person. Be sure to ask about military and senior discounts.
- Event registration fee is \$175 per person prior to June 1 and \$200 per person on or after June 1. Each registration fee provides delegate with one ticket to the Opening Icebreaker, Vanguard Banquet and President's Breakfast. Requests for refund of registration fees (minus \$25 administrative fee) must be submitted in writing prior to June 30. Additional event tickets will be available at the NCOA Registration Table at the Convention. Individual tickets costs are: Opening Icebreaker \$60, Vanguard Banquet \$80, President's Breakfast \$40.
- Invitations have been issued for guest speakers for the Opening Ceremony and the Vanguard Awards Banquet. Additional information will be available on the conference website (www. ncoaconference.org) as speakers are confirmed.
- An NCOA Job Fair will be held at Nellis AFB on Tuesday, July 11.
- An exciting new twist is being added to the Opening Icebreaker as well as several informative break-out sessions being added to the agenda.

- ➤ Dress for most events is casual business attire. Active duty military are asked to wear dress uniform with short sleeves and open collar during the Senior Enlisted Panel. The Opening Icebreaker will provide delegates the opportunity to re-connect with old friends and make new ones, dress is casual. The Vanguard Banquet is semi-formal and the President's Breakfast is casual. Knights of the Square Table will set dress requirements for all Knights' events.
